Test strips are available and used to verify the solution is at a concentration necessary to achieve sanitization.</p>
<p>Violation #56. Ventilation & lighting Observed light out above the pan storage area. Replace light.</p> <p>CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.</p>
