Violations Comments

Violation #56. Ventilation & lighting

Lighting in the kitchen where food is worked with still does not hit the 50 footcandle requirement. Lights between 30-33 footcandles in areas where not directly under lights/where lights are dimming. Lighting around 44-48 footcandles in areas directly under where lights have been replaced. Lights that are yellow in color appear dimmer, not putting out enough light. Observed bulb out in lighting fixture in between chemical and locker room area. Replace burnt out light and dimming lights. Per manager, will have maintenance replace bulbs.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
