Violation #56. Ventilation & lighting

Lights appear to be starting to dim in food prep areas. Area near the dishmachine working surface about 30-32footcandles and area near the laundry room/restrooms at about 40-44footcandles. Surfaces where food is worked with shall be at least 50 footcandles. Increase lighting so that at least 50 footcandles can be reached at the surface area where food worked with.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
