Blount County Parent and Family Engagement Policy

GENERAL EXPECTATIONS

The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1116 of the Every Student Succeeds Act (ESSA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.

Parent/Family Engagement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—

- a) That parents and families play an integral role in assisting their child's learning;*
- b) That parents and families are encouraged to be actively involved in their child's education at school;*
- c) That parents and families are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and*
- d) That other activities are carried out that will build the capacity of all parents and families.*

THE BLOUNT COUNTY SCHOOL DISTRICT WILL:

- Involve parents and family members in jointly developing the local educational agency plan under section 1112, and the development of support and improvement plans under paragraphs (1) and (2) of section 1111(d) of ESSA.
- Coordinate and integrate parental involvement programs that encourage and support parents and families in more fully participating in the education of their children.
- Provide timely notice if a student has been assigned, or has been taught for 4 or more consecutive weeks by, a teacher who does not meet applicable State certification or licensure requirements at the grade level and subject area in which the teacher has been assigned.
- Ensure parents are informed of their right to request (and receive) information regarding the professional qualifications of their student's classroom teachers.
- Conduct, with the involvement of parents, an annual evaluation of the LEA Parent Engagement Policy and Plan.
- Educate teachers, instructional support personnel, principals, other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs and build ties between parents and the school.
- Provide assistance, materials, and/or training to parents and families of participating Title I children in understanding such topics as the challenging state academic standards, State and local academic assessments, the requirements of Title I, Part A, and how to monitor their children's progress and work with educators to improve their achievement.
- Use technology, as appropriate, to foster parental involvement.
- To the extent feasible and appropriate, provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports in a language such parents understand.

- Supplying informational resources for the Parent Resource Corner at each Title I school
- Providing information regarding opportunities for parent involvement in a language parents can understand
- Serving on school advisory committees, if requested
- Providing parent training sessions for parents, as requested or needed
- Providing materials for schools to use in parent trainings, as requested or needed
